"China's unfair and illegal trade practices have inundated the market with dumped solar panels, undercutting the US ability to compete," said the group. ... "This is likely to greatly reduce import levels, as occurred in the second quarter of 2022 when the anti-circumvention case was filed. If these duties are passed along to buyers ...

US duties vary depending on the panel supplier. The China-wide rates are 238.95% in anti-dumping duties and 17.10% in countervailing duties. Some companies qualify for lower rates after presenting evidence to Commerce. JA Solar and Risen panels are subject to countervailing duties of 18.49% and 15.71%, respectively. Jinko and Risen solar panels ...

“That is the reason in the solar space, we have applied for anti-dumping duty, because the Chinese sell below the cost of production,” said Kheruka adding “It is very easy to prove, in fact, the selling prices do not even cover the raw material and power and fuel cost”.
