These restrictions may limit the size of the battery, or may prohibit shipping altogether. Customs Regulations. If you're shipping an e-bike overseas, you'll need to comply with the customs regulations of the destination country. This may involve filling out customs forms, paying import duties or taxes, or providing additional documentation.

The implementation of import tariffs in countries you're exporting to, and/or export duties at home, could cost your business a significant amount in sales. This was seen recently in the US-China Trade War, in which China placed tariffs on \$110 billion USD worth of US imports in 2018.¹²

5. Certificate of Free Sale. Sometimes called a "Certificate for Export" or "Certificate to Foreign Governments," a Certificate of Free Sale is evidence that goods--such as food items, cosmetics, biologics or medical devices--are legally sold or distributed in the open market, freely without restriction, and approved by the regulatory authorities in the country of ...

You need to find out the watt-hours rating of the lithium-ion battery, which can be located on the battery itself or by contacting its manufacturer. Watt-hour ratings indicate how much power the battery can produce in one hour. To transport a lithium-ion battery in a hard case, it must have a rating below 100 watts per hour.
