The Indian government will start imposing a basic customs duty (BCD) on solar module and cell imports from April 1, 2022, it announced this week. The Ministry of New and Renewable Energy (MNRE) said the levy was set at 40% for photovoltaic (PV) modules, while a 25% duty will be imposed on solar cell imports.

In FY 2021-22, the HS Code 85414011 was retained for Solar PV Cells and new HS Code 85414012 was brought in for Solar PV Modules. Subsequently, from FY 2022-23, the Solar PV Cells and Solar PV Modules (other than those exclusively used with ITA-1 items) are put under HS Codes 85414200 and 85414300 respectively. ... Individual countries can extend the HS code up to 10 digits to further classify goods for customs or export purposes. These extensions are commonly referred to as Tariff Schedules and can help you estimate duty and tax information.

MNRE had proposed 40 per cent BCD on solar module with CTH code "85414012" and 25 per cent BCD on solar cell with CTH code "85414011" effective from April 1, 2022. However, the Finance Ministry has also advised that the customs notification in this regard would be issued at appropriate time.

According to TARIC, customs duty for photosensitive semiconductor devices, including photovoltaic cells whether or not assembled in modules or made up into panels; light-emitting diodes, code 8541409000, is 0%. In the HTS tariff system, the duty for solar cells assembled into modules or made up into panels (code 8541.40.60.15) is also 0%.

Because a solar cell tariff adds additional costs to any solar modules imported from another country, it makes buying cheaper solar modules from overseas less appealing than paying for a panel manufactured domestically. If the solar cell tariff is high enough, domestic solar distributors can become competitive in the industry, while still ...
