Administrative penalties apply when entries are considered to be materially incorrect, which means there are errors or omissions (that you don't voluntarily disclose before any action is taken by Customs) for any of the following: (found in section 284 of the 2018 Act)

9.3 Generally, "mens rea" is not required to be proof for the imposition of penalty under the provisions of the Customs Act. The amount of penalty depends on the gravity of the offence and is to act as a deterrent for the future. 9.4 Section 125 of the Customs Act, 1962 provides for option to pay fine in lieu of confiscation.



The 2026 deadline can be found in Article 13, which states: "Labeling and marking of batteries - From 18 August 2026 or 18 months after the date of entry into force of the implementing act referred to in paragraph 10, whichever is the latest, batteries shall bear a label containing the general information on batteries set out in Part A of Annex VI."
