Chapter 27, Section 2702.2.17 specifies that standby power shall be provided for smoke control systems where required.

The importance of smoke control systems and NFPA 92

A smoke alarm with a dead or missing battery is the same as having no smoke alarm at all. A smoke alarm only works when it is properly installed and regularly tested. Take care of your smoke alarms according to the manufacturer"s instructions. Below are some general maintenance tips. Smoke alarm powered by a 9-volt battery. Test the alarm monthly.
