Procedural background. The Foreign Subsidies Regulation (FSR) began on 12 July 2023. It's a new set of rules that enables the commission to address distortions caused by foreign subsidies. It thereby allows the EU to ensure a level playing field for all companies operating in the internal market while remaining open to trade and investment.

Existence of a Foreign Subsidy. A foreign subsidy is defined in Article 3(1) of the FSR as a financial contribution provided directly or indirectly by a non-EU country, which confers a benefit on an undertaking engaging in an economic activity in the EU and is limited, in law or in fact, to one or more undertakings or industries.
