This label or sticker must clearly indicate that the package contains lithium batteries. It should be placed on a visible and accessible location on the outer packaging. 2. Transport of Dangerous Goods by Post in accordance with Section 2.4 of the IATA Regulations. Section 2.4.1: The Universal Postal Union Convention forbids the carriage of Dangerous Goods in mail except as permitted ...

UN 3090, lithium metal batteries (including lithium alloy batteries) are prohibited from carriage as cargo on Jetstar aircraft. This applies to Section IA, IB and Section II of ...
