Failing to register a new battery may result in premature failure due to overcharging or undercharging. BMW introduced battery registration in select 2002 models, and by 2005, most BMW models mandated this process. If your BMW predates 2002, battery registration is not necessary.

All manufacturers of lithium-ion batteries must undergo testing of their products in BIS-accredited laboratories and subsequently register with BIS. To obtain a BIS license for lithium-ion batteries, it is imperative to ...
