



# Solar panels are on China's anti-dumping list

Mumbai: DGTR has recommended anti-dumping duty of up to \$577 per tonne for five years on imports of aluminium frames for solar panels from China. The probe was carried out through the Directorate General of Trade Remedies (DGTR), which is the investigative arm of the Ministry of Commerce and Industry.

India has initiated an investigation into the import of aluminium frames for solar panels from China, following a complaint by a domestic manufacturer. If found guilty of dumping, anti-dumping duties may be imposed to protect the domestic industry. Learn more about India's efforts to address cheap imports and promote fair trading practices.

Seven global solar manufacturers accuse Vietnam, Thailand, Malaysia, and Cambodia of dumping solar panels and batteries on the United States market and call for imposing import tariffs, while directly implicating Chinese companies behind the scenes. Solar energy is believed to be a new battleground in the U.S.-China tech war.

The petitioners said the US solar "manufacturing renaissance" was threatened by heavily subsidized Chinese cells and modules. "China's unfair and illegal trade practices have inundated the market with dumped solar ...

It is the largest dumping complaint the EU has ever received with regards to affected import value. China is accused of providing subsidies to solar panel producers who export their products below market value, thereby causing unfair competition. If found guilty, Chinese companies might have to pay anti-dumping duties.

Currently, China's solar panel products are being subject to anti-dumping taxes from 15.85% to 238.95% by the United States and anti-subsidy taxes from 11.97% to 15.24%. The law bans imports into the US of goods made by forced labor in the Xinjiang region in China, effective from 21 June 2022.
