



# Tax rates on solar panel sales

Solar Sales Tax Exemption in Wisconsin. Wisconsin imposes a 5% sales tax on all purchases. But thanks to Wisconsin's solar sales tax exemption, qualifying solar equipment is exempt from that sales tax. With an average solar project cost in Wisconsin of \$23,240 and a state tax rate of 5%, most homeowners will save an average of \$1,162.

The partial exemption reduces the state sales and use tax rate by 3.9375% and is set to expire on July 1, 2030. Second, electricity delivered through "mains, lines or pipes" is exempt from sales and use tax. In general, the sale of electricity is exempt from sales tax.

The first incentive that would kick in for a solar system in Connecticut is the sales tax exemption that applies to residential solar, geothermal, and other distributed clean energy technologies. The sales tax exemption applies to the 6.35% state sales tax. For a \$25,000 system, that amounts to \$1,587.50 that you won't pay in sales tax.

Similarly, Massachusetts offers a sales tax exemption for solar panel installations. The current state sales tax

Residents who install solar panels before the end of 2024 will be exempt from increased property taxes. Sales tax exemption: You won't have to pay sales and use tax on solar equipment in California.

Furthermore, through Finance Act, 2022, exemption of sales tax on import and supply of photovoltaic cells whether or not assembled in modules or made up into panels was restored through insertion of S. No. 164 of Table-1 of the Sixth Schedule to the Sales Tax Act, 1990 while all other accessories/ related items of solar panels remained taxable ...

The Solar Energy Production Tax rate is \$1.20 per megawatt hour produced. The Solar Energy Production Tax applies to SEGS with an alternating current (AC) nameplate capacity exceeding 1 megawatt. SEGS with an AC nameplate capacity of 1 megawatt or less are exempt from the Energy Production Tax.
