Other exemptions include the sale of an unloaded antique weapon to a licensed collector, or an "infrequent" sale of a firearm. The exemption for the infrequent sale of a firearm is further defined under California Penal Code 16730. Here, the law states that when the firearm is a handgun, there must be less than 6 handgun transactions a year.
