When an electric car battery's performance drops to 70% or less, its "second life" revs into action. There's still residual life in the viable battery, so it can be hung in your garage or in the cupboard under the stairs as a static battery energy storage system, if you have a renewable energy source like solar panels.

When purchasing a new car battery, buying one with a warranty spanning at least two years is best. Several battery manufacturers have warranty coverage for more extended periods.

For example, if your battery company provides a throughput warranty of 30 MWh, the warranty is valid until the battery stores and delivers 30 MWh-or 30,000 kilowatt-hours (kWh)-of energy. Like a cycle life warranty, throughput warranties typically only apply if your battery delivers a set amount of energy before its warranty period.

Even though they're under no obligation to help with repair costs after the warranty, manufacturers may choose to make a goodwill contribution towards repair costs, particularly if the failure was shortly after the end of the ...

For example, my Everstart Maxx battery is 42 months old (3 and a half years old), is no longer eligible for a free replacement, is tested dead but I need a new battery. According to my warranty, I have 18 months left or 30 percent remaining. If a new battery is still \$93.76 I get a \$28.13 discount off that new battery price.

So if you just bought a 10 kWh battery, the manufacturer is guaranteeing that your battery should be able to store up to at least 7 kWh of energy by the time your warranty expires.

EV Battery Health Quick Tips. According to the U.S. Department of Energy, modern EV batteries will last anywhere from 12 to 15 years in moderate climates and between 100,000 and 200,000 miles ...

A battery should be charged with a current no greater than 20% of its capacity. For example, if the battery has a 100 amp/hour rating, its maximum charge current should be no greater than 20amps. A discharged battery is able to accept much higher rates of charge - for a short time - but this kind of charging should be avoided.

The battery problems seen on early Leafs has unfortunately tainted all BEVs in general. If a battery has one or more defective cells, those cells will be changed individually (to my knowledge) within warranty. If the whole battery pack is evenly degraded to less than 70 % capacity, I'll assume you'll get a new battery all together.
