While IATA doesn't require that you submit an MSDS or UN 38.3 test report, your freight forwarder or air courier (i.e., Fedex or DHL) will certainly do so.

US import regulations require that lithium batteries conform to specific safety and testing standards before they can be imported. Compliance with the UN Manual of Tests and Criteria is mandatory, which includes rigorous testing to ensure safety during transport. Non-compliance can lead to fines and restrictions on importing these batteries.

Out of the 2019's 316 gigawatt-hours (GWh) of global lithium cell manufacturing capacity, China accounted for 73 percent of the capacity.

Lithium batteries are classed as "Dangerous Goods", which means there are certain limitations on how they can be shipped. A charged lithium battery can, under very particular circumstances, catch fire. This means that if you ship charged lithium batteries in bulk, there's an increased risk of fire on the vehicle that is shipping them.

On December 23, 2020, the "Regulation of the Ministry of Commerce No. 100 of 2020 on the provisions for the import of used lithium batteries as raw materials for the lithium battery industry" was enacted in Indonesia with the aim of supporting and promoting the development of the domestic electric vehicle industry.
